Secure as many golf balls as you like for the Helicopter Ball Drop. Your name will be associated with the numbers that are written on the golf ball(s) you secured. The golf balls will be dropped out of a helicopter onto the green, and the golf ball or balls in the hole will win the Grand Prize of \$5,000!* Balls can be secured online at smhf.org, at the VIP reception for sponsors on April 29, 2021 or at the golf tournament from 9:00 a.m. -10:00.a.m., May 7, 2021 at Laurel Oak Country Club. Participants must be 18 years or older to enter the Helicopter Ball Drop.

Helicopter Ball Drop Rules:

1. Minimum suggested donation is \$25 (per golf ball) or 5 golf balls for \$100. Each participant will be entered into the Helicopter Ball Drop. The drop will take place on Friday, May 7, 2021 at Laurel Oak Country Club's Driving Range in Sarasota, Florida prior to tournament tee-off.

2. Participants may enter more than once. Participants will be assigned a number for each ball secured. No purchase required to participate.

3. On Friday, May 7, 2021, the numbered golf balls will be placed randomly in a bucket, flown in a helicopter and dropped above the driving range at Laurel Oak Country Club. The participant whose golf ball goes into the hole will receive a cash prize of \$5,000. If more than one golf ball goes into the hole, then the cash prize will be split equally among the owners of the golf balls found in the hole.

4. *If no golf ball goes into the hole, then the golf ball landing closest to the hole will win. The golf ball closest to the hole will be determined by measuring the distance from the center of the hole.
